

# 2007 Post-Election Legislative Report: An Analysis of Voting Trends on Referred Law 6 by Legislative District

#### **INTRODUCTION**

To state the results of the 2006 Election on Referred Law 6 most plainly, the voters have spoken. On the issue of abortion, a strong majority of South Dakotans oppose government intrusion into a very difficult and private medical decision. Keeping with the will of voters, future attempts to ban abortion should be rejected.

The abortion ban passed by the South Dakota Legislature in 2006 (a/k/a HB 1215, and later, Referred Law 6) was referred to the voters of the state and rejected by a wide margin. While the overall result of this election is significant, a closer look at geographic voting trends across the state demonstrates how many legislators were out of touch with their constituents on the issue of reproductive rights.

The following analysis will be useful to legislators who may want to reexamine their position on this issue, local and statewide media covering the 2007 Legislative Session as well as concerned citizens who want to learn more about how their elected officials voted on the abortion ban and whether they are truly representing their constituents.

#### **OVERVIEW**

Statewide voting results on Referred Law 6 demonstrate that opposition to the abortion ban crossed virtually all geographic boundaries. Looking at geographic divisions in the state, the question is not whether a particular group of voters would support or oppose a ban, but rather by what margin are they likely to oppose the measure.

- In the 2006 General Election, 334,593 South Dakotans cast a ballot on Referred Law 6. Of those, 185,945 (55.57%) voted No and 148,648 (44.43%) voted Yes.
- In 32 of 35 Legislative Districts, over 50% voted to overturn the abortion ban.
- Of the 73 Senators and Representatives that voted for passage of HB 1215, 65 were effectively vetoed as a majority of their constituents voted No on Referred Law 6.
- There were five instances where 100% of a district's delegation voted to pass HB 1215, only to be overridden by a supermajority of the constituency. All three representatives for districts 15, 24, 30, 31 and 35 voted for the abortion ban. In each of these Districts, more than 60% of voters rejected the ban.
- Over 50% of voters in 43 out of 66 counties in South Dakota rejected the abortion ban.

#### NOTABLE DIFFERENCES

#### **District 10**

Rep. Roger Hunt, the primary sponsor of the abortion ban, along with fellow Republicans Sen. Gene Abdallah and Rep. Shantel Krebs all voted in favor of HB1215. Residents of their District disagreed and overturned the measure by a vote of 54% to 46%.

#### **District 15**

Three Democrats represent District 15: Sen. Gil Koetzle, Rep. Mary Glenski and Rep. Kathy Miles, all three of whom voted to approve the abortion ban. Voters in District 15 rejected the abortion ban by a wide margin: 61% to 39%. Rep. Miles was a spokesperson for VoteYesForLife.com and her husband, Jim, served as the group's treasurer.

#### **District 24**

All three delegates from District 24 (Sen. Bob Gray, Rep. Tim Rounds and Rep. Ryan Olson) voted for the abortion ban. Voters in the District disagreed with them strongly and voted 63% to 37% to reject the law.

#### **District 29**

Rep. Larry Rhoden, an outspoken supporter of the abortion ban, represents District 29 with two of his fellow Republicans, Rep. Thomas Brunner and Sen. Kenneth McNenny. While all three voted in favor of the abortion ban, their constituents rejected the measure by a vote of 59% to 41%.

#### Districts 30 and 31

The entire delegation from both Districts 30 and 31 supported HB 1215. Their constituencies disagreed; 61% of voters in District 30 and 64% of voters in District 31 voted to overturn the ban.

#### **District 35**

District 35 is home to Sen. Bill Napoli, whose comments regarding an "exception" to the abortion ban received national attention after airing on national public television. In 2006 he, along with Rep. Jeffrey Haverly and Rep. Alice McCoy (who is not returning to Pierre this year) voted to approve the abortion ban. Residents of their District rejected the measure by a vote of 62% to 38%.

#### **House and Senate Leadership**

House and Senate Leadership in 2006 consisted of Senate Majority Leader Eric Bogue, Senate Minority Leader Garry Moore, House Majority Leader Larry Rhoden and House Minority Leader Dale Hargens. All four of these individuals voted to approve HB 1215 and each of their respective districts voted to overturn the abortion ban.

#### The Oglala Sioux Tribal Council

Following passage of HB 1215, Oglala Sioux President Cecelia Fire Thunder proposed a women's health clinic on the reservation. The Tribal Council subsequently voted to impeach Fire Thunder and banned all abortions on the reservation. The tribe is comprised of three counties – residents of those counties voted in strong majorities to repeal the abortion ban (Shannon – 64%; Jackson – 56%; and Bennett – 59%).

#### **OUT OF TOUCH – ACROSS PARTY LINES**

Polling completed during the course of the campaign and the election results indicate that this is not a strictly partian issue in South Dakota. It also appears that members from both political parties were out of touch with their constituents.

- Sixteen Senators returning to Pierre were out of touch with their Districts. Four of those are Democrats and twelve are Republicans.
- Thirty-two Representatives returning to Pierre were out of touch with their Districts. Six of those are Democrats and twenty-six are Republicans.












# RL6 Vote By District
